Along with the standardized, original recipe, Program Advisors of FUTP60 schools must also submit a photo of students promoting, making, and/or taste testing the recipe, along with a written description (maximum 250 words) of how the recipe is nutritionally beneficial (Limit one recipe, photo and written description entry per school).
