

SWEEPSTAKES RULES FOR DENVER BRONCOS VIP EXPERIENCE
NO PURCHASE NECESSARY TO ENTER OR WIN

- 1. Eligibility:** K-12th grade schools in Colorado are eligible for these Sweepstakes. FUTP 60 Student Teams in schools or districts which do permit student participation in the Sweepstakes or which do not or are unable to agree to these Sweepstakes Rules are not eligible to participate. Employees of Dairy MAX, Inc. (Dairy MAX or Sponsor), the NFL Entities (as defined below), their respective parents, affiliates, subsidiaries, advertising or promotion agencies or other individuals engaged in the development, production, or distribution of promotion materials and persons who are immediate family or who reside in the same household as persons in the preceding categories are not eligible to participate. The postcard must include the Entrant's email address, telephone number, or mailing address so that they can be notified if selected as Winner. Postcards must be postmarked by December 15, 2022.
