

# Tell Me Something Good Sweepstakes 2023 – Child Nutrition

## OFFICIAL SWEEPSTAKES RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. MANY WILL ENTER, FEW WILL WIN.**

**Eligibility:** Entry is open to any staff member of a School Nutrition Department at a school located in Texas, Colorado, Louisiana, \*Western Oklahoma, New Mexico, \*\*Southwest Kansas, Wyoming or Montana that participates in USDA’s National School Lunch and/or National School Breakfast Program and who is at least 18 years of age at the time of entry. Employees of Dairy MAX, Inc. (“Dairy MAX” or “Sponsor”), the NFL Entities (as defined below), their respective parents, affiliates, subsidiaries, advertising or promotion agencies or other individuals engaged in the development, production, or distribution of promotion materials and persons who are immediate family or who reside in the same household as persons in the preceding categories are not eligible to participate. **To Enter:** Submit your story via [Submittable application](#) and include the following items: 1) Photo of your child nutrition team in action – Up to three (3) photos can be submitted on the application (JPG or PDF), 2) Description of photo(s) and 3) If a student’s face is shown in the photo(s), a [“Signed Photo Release”](#) must be submitted with each photo on the application. Submission will not be complete if the necessary student Photo Release is not received. A free account must be created on Submittable prior to submission. Additional information will also be requested on the application (name, email, district, phone etc.). As an alternative method of entry, the Sweepstakes may be entered by mailing a postcard to Dairy MAX at 2214 Paddock Way Drive, Suite 600, Grand Prairie, TX 75050. The postcard must include the Entrant’s email address, telephone number, or mailing address so that they can be notified if selected as Winner. Postcards must be postmarked by February 10, 2023.
